As a Clusters Clothing Sale Seller, I understand and agree to the following policies as well as those stated in the Sale *Rules & Guidelines* found on the website:

- Clusters has the right to deny selling privileges to any member not in good standing with the Club. *All Sellers must have their dues paid to Treasurer Danielle Glodowski no later than August 14, 2013.*
- Sellers must submit two (2) separate checks, **payable to Clusters**, along with the completed registration form to Committee Chair Beth Ryan no later than *August 14, 2013*. Late registrations *will not* be accepted.
- Sellers who wish/need to cancel their registration must contact Committee Chair Beth Ryan by *August 14, 2013* in order to receive their full refund. *No refunds will be given after August 14, 2013.*
- If I am a New Seller, I understand that I am required to attend the New Seller's Meeting on *May 21, 2013 or June 27, 2013* in order to receive my Sellers Number, as well as hanging and tagging instructions, etc.
- Sellers will be assigned duties for set-up and day of sale and will be responsible for completing these tasks at the assigned times. Failure to fulfill these responsibilities at the assigned times, *even in an emergency*, will result in forfeiture of the Seller's \$40 deposit check.
- **Committee members are required to start on Friday at 1:00 p.m. or 3:00 p.m. based upon assignment and work until they are released on Friday night. All Committee members are required to start on Saturday at 6:15 a.m. and work until they are released on Saturday afternoon. Failure to fulfill these responsibilities at the assigned times, even in an emergency, will result in forfeiture of the Committee member's \$40 deposit check**

The following items are prohibited at all sales:

- Infant carriers, car seats and/or booster seats per recommendation by TP Police
- Stuffed animals
- Drop side cribs
- Crib tents
- Any items that were not used for, belonging to or purchased for your children
- You cannot sell your own clothing – only your maternity clothes and clothing for your children
- You can only sell items that are labeled as maternity clothing that were purchased at a maternity store or from a maternity clothing line.
- Any item that does not fall within the season of the sale, see below:
- Please only sell Fall & Winter items including Halloween, Thanksgiving, Christmas, Valentine's Day and/or St. Patrick's Day items, winter coats, boots, hats & gloves, costumes, sweaters, fleece pants/tops/pj's, flannel, corduroy and turtlenecks. Short sleeve T-shirts *are* allowed.
- Please **DO NOT** sell swimsuits or cover-ups, tank tops, halter tops, sundresses, spaghetti strap dresses or tops, shorts, capris, summer hats, sandals or flip flops, pool toys, spring/lightweight jackets, pajamas with shorts, rain coats or boots, white dress shoes, roller skates, water shoes, Easter or 4<sup>th</sup> of July items.
- Any clothing item that is ripped, torn, stained, missing buttons, has broken zippers or is overly pilled or worn, no matter the price.
- Any equipment item that does not contain all parts, is not in proper working condition or is dirty, stained or damaged.

In addition:

- Each item *must* display an official Clusters tag complete with the necessary information (name & number, price, size, sex, # of pieces, etc.).
- Each tag *must* be securely attached with safety pins on the "PIN HERE" area of the tag and *must* be displayed on the *upper left-hand side* of the front of the item when the item is facing you.
- Each item *must* be hung securely and form the letter "C" when the garment is facing you. Items should be pinned to the hanger to prevent the item from falling off the hanger.
- **BATTERIES ARE MANDATORY FOR ANY ITEM, TOY, ETC. THAT REQUIRE THEM.**

*Any item that does not meet these requirements will be pulled from the Selling Floor. Selling privileges may be revoked if a large number of items are pulled due to the above factors.*

- Clusters is not responsible for lost, stolen or mis-tagged items or errors in calculation.
- Clusters does not impose any pricing practices with the exception that no clothing items be priced for less than \$1.00.
- Clusters will collect 15% of my total sales. If I am a member of the Clothing Sale Committee, Clusters will only collect 10% of my total sales.
- Sellers' checks and tags will be available at the meeting in the month *following* the sale (FALL Sale/October meeting; SPRING Sale/April meeting). Any Seller that does not attend the meeting will have *only* their checks mailed to them on the following day. Sellers who do not attend the meeting must make arrangements to pick up their tags from Treasurer Danielle Glodowski's house. Tags *will not* be mailed.
